# RECENT CaCTI ACHIEVEMENTS



• Provide Speed Setting Flexibility:

**AB 43 (Friedman) and AB 2336 (Friedman) speed setting:** grants local authorities greater flexibility in setting speed limits based on the recommendations of the Zero Traffic Fatality Task Force

• Support Creation of Vehicle Weight Task Force:

**AB 251 (Ward)** requires the **California Transportation Commission** to convene a vehicle weight study task force.

• Paid Parking Flexibility:

**SB 532 (Weiner)** created a pilot program to allow for meterless paid parking zones in three California cities

• Speed Safety Camera Legislation:

Five of eight CaCTI cities are part of a pilot program established by **AB 645 (Friedman)** that authorized the use of speed safety cameras.

• Support Funding for Active Transportation Programs:

CaCTI has worked with a coalition of stakeholders to maintain funding in the state budget for the **Active Transportation Program (ATP)** which has been facing severe cutbacks/elimination.

• Protecting Mobility Data:

CaCTI defeated legislation that would have severely limited the availability of data from mobility devices (2020: AB 1112, AB 3116 and 2021: AB 859)
